LOG FILES

Kadio.fr and dropship-master.com follow a standard procedure for using log files. These files record visitors when they visit websites. All hosting companies do this and are part of the hosting service reviews. Information collected by log files includes Internet Protocol (IP) addresses, browser type, Internet Service Provider (ISP), date and time stamp, referring / referring pages. exit and possibly the number of clicks. These are not linked to any personally identifiable information. The purpose of the

information is to analyze trends, administer the site, track user movements on the website, and collect demographic information.

COOKIES AND WEB BEACONS
